Education- The Ann Arbor Art Center education programs provide an array of experiential learning opportunities for a diverse and evolving audience, serving youth and adults at all skill levels ranging from beginner to advanced. Annually, the Art Center offers 200+ classes, one-day workshops, camps, and free drop-in workshops and all are taught by experienced instructors with MFA, BFA, or art education degrees. In addition to holding classes in our downtown Ann Arbor facility, we partner with other community groups to hold classes at their locations as well (University of Michigan Museum of Natural History, White Lotus Farms, and Hathaway's Hideaway.) In 2017, over 2,500 individuals of all ages participated in educational programming.

Galleries- The Galleries programs at the Ann Arbor Art Center engage over 1,500 local, regional and national artists through curated and juried installations in the 117 Gallery, site-specific installations in the Aquarium Gallery, through sale of artwork in the Gallery Shop, and through a series of offsite pop-up art shows. The galleries program also hosts educational programming alongside each exhibition, including professional development and networking events for artists.
